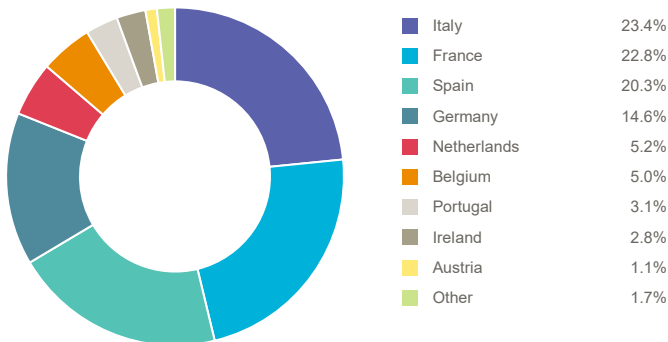

FUND DESCRIPTION

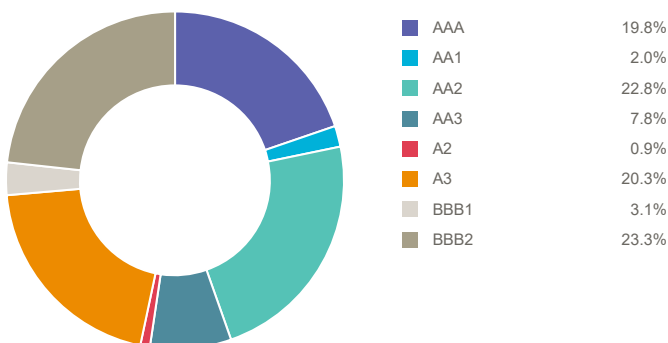
