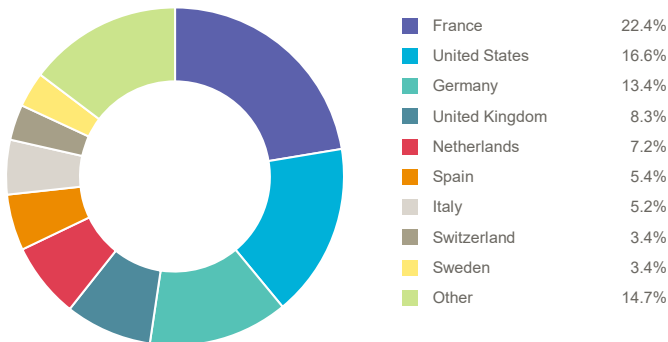

FUND DESCRIPTION

This fund is passively managed and invests in Euro-denominated investment grade large cap corporate bonds. The fund aims to perform in line with the Bank of America Merrill Lynch EMU Large Cap Corporate Index. Qualifying bonds must have a maturity of greater than one year, a fixed coupon schedule and a minimum amount outstanding of EUR 500 million. Bonds must be rated investment grade based on a composite rating.

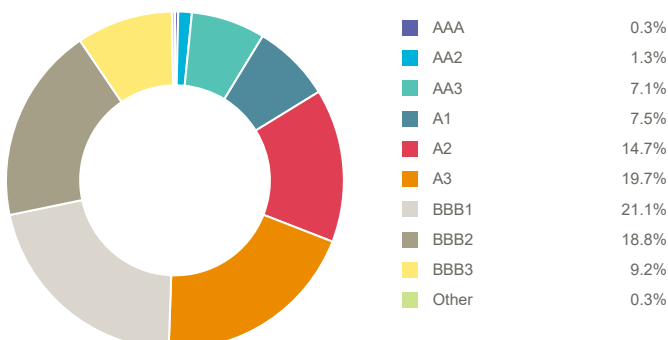
BOND COUNTRY DISTRIBUTION

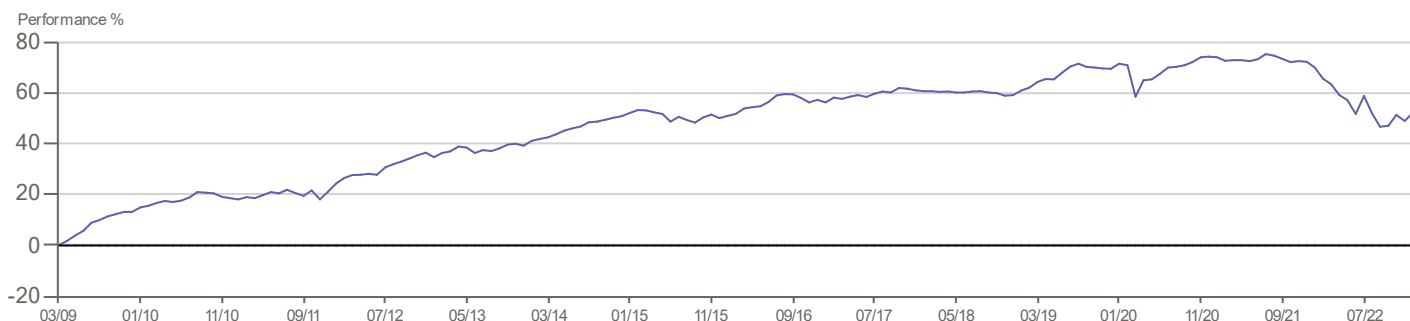
