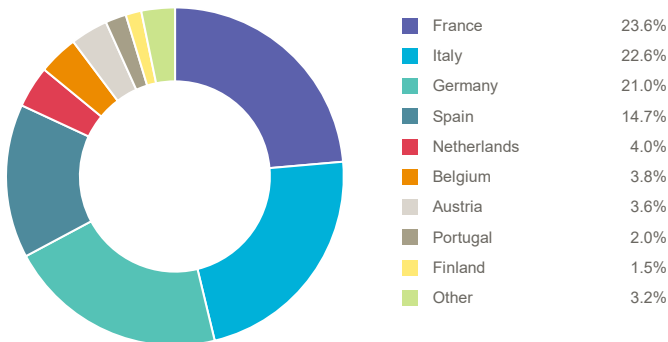

FUND DESCRIPTION

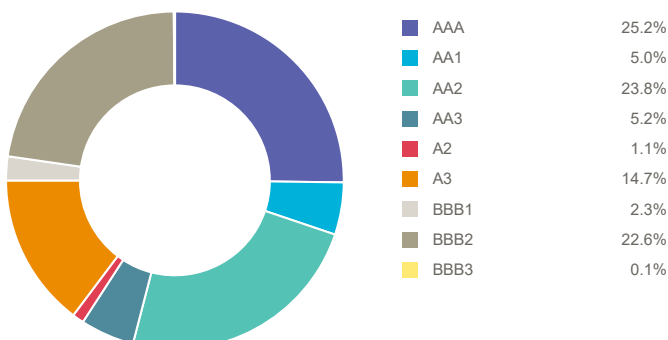

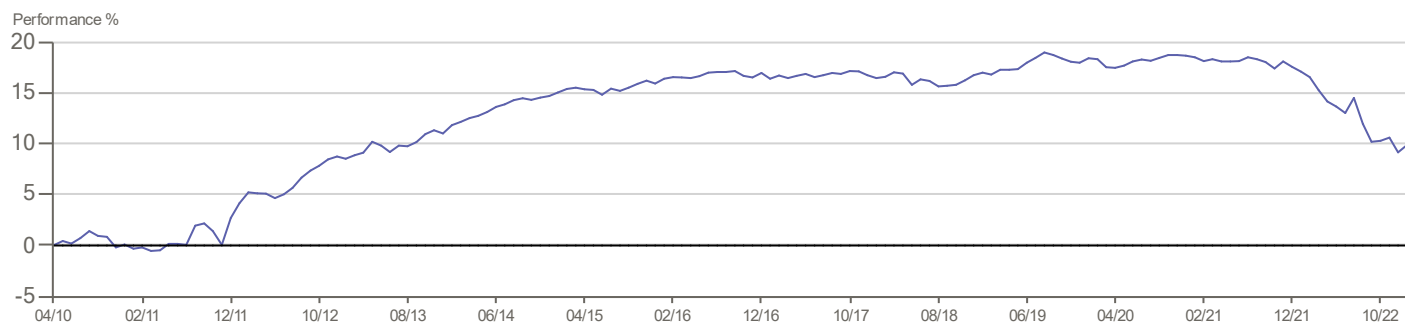
