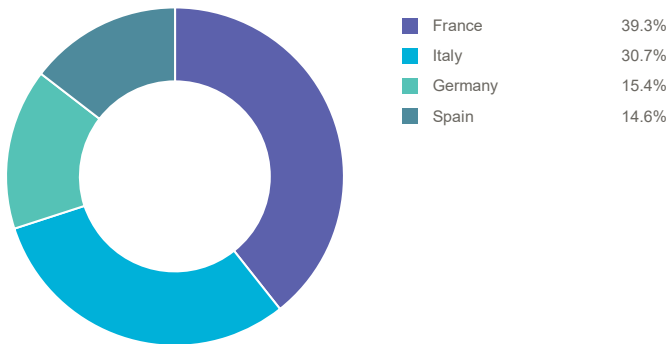

FUND DESCRIPTION

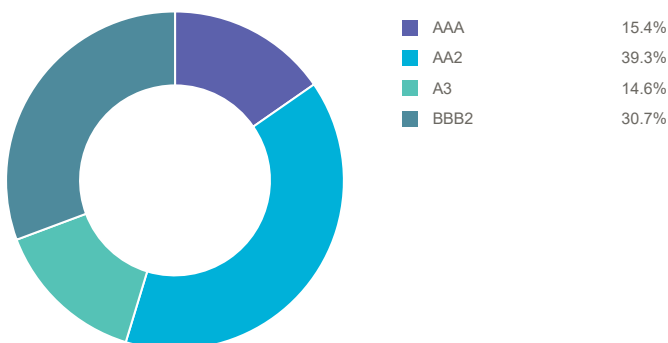

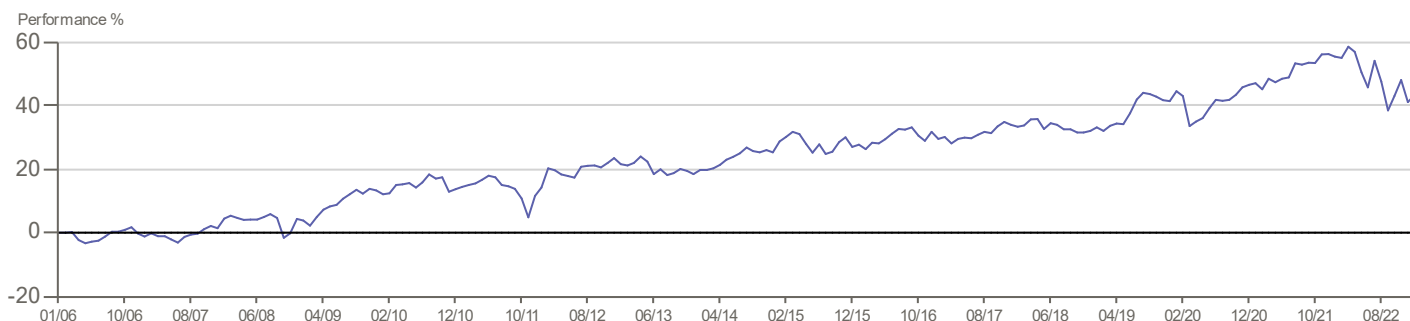
