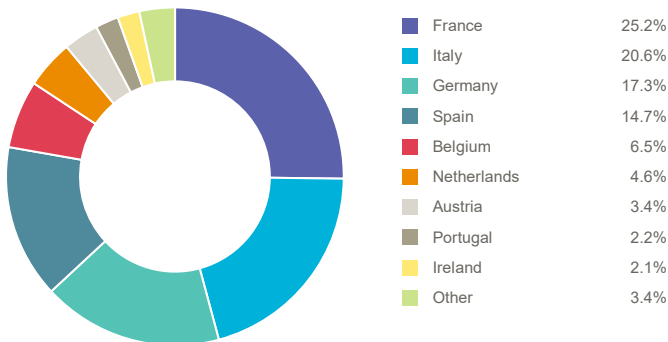

## FUND DESCRIPTION

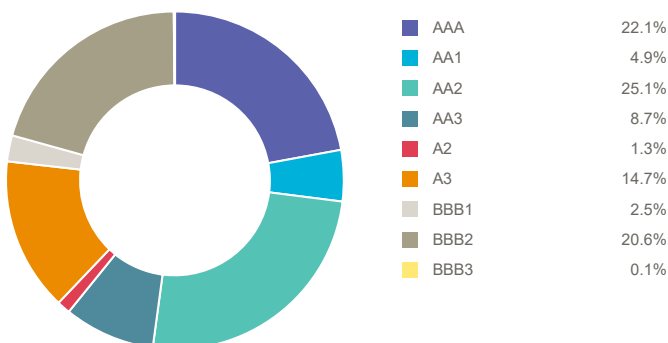
