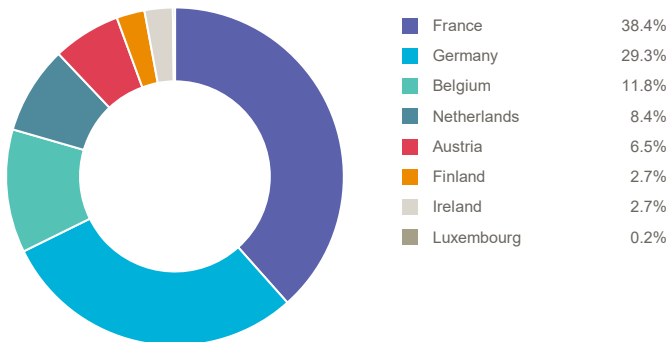

FUND DESCRIPTION

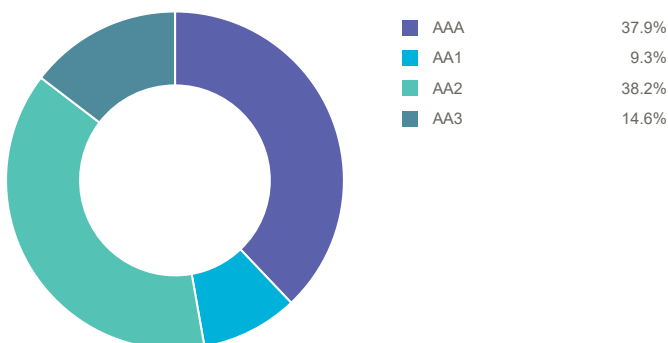
