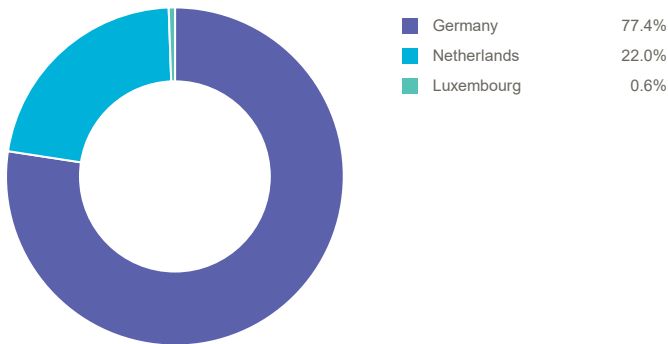

FUND DESCRIPTION

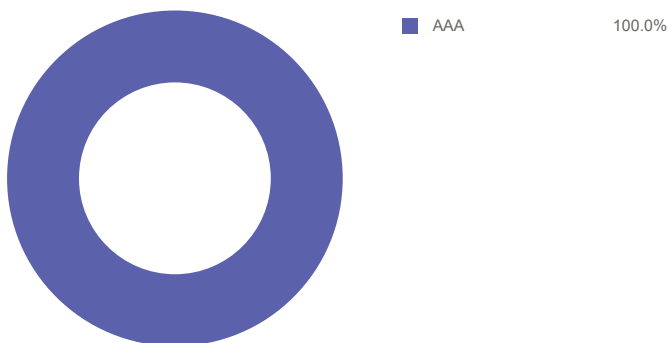
