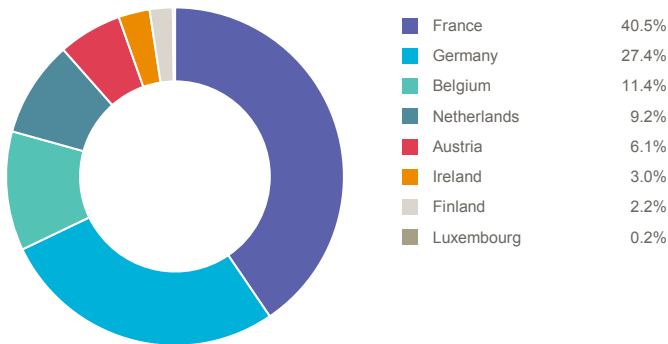

FUND DESCRIPTION

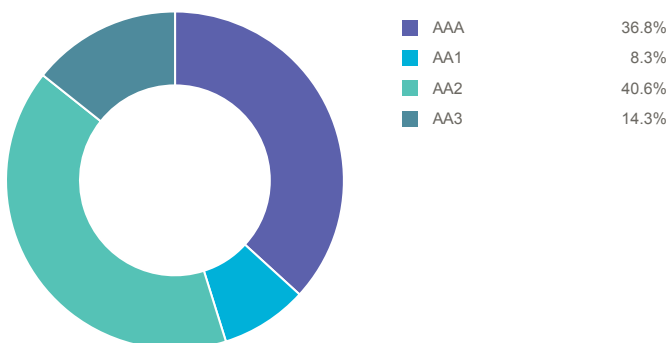
