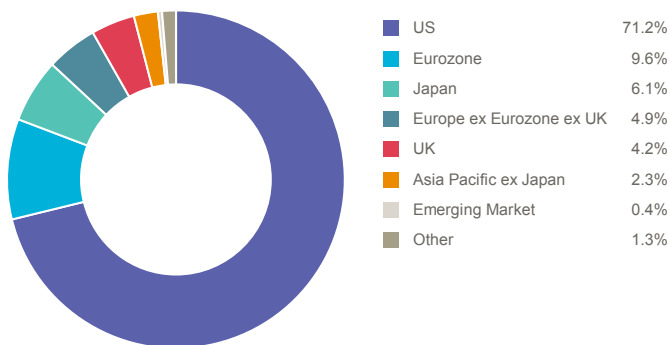

The Indexed World Equity Fund is a passively managed fund that invests 100% in World Equities. The fund aims to perform in line with its benchmark Index with 40% of the non Euro currency exposure hedged. 40% of the non-Euro currency elements of the Fund are hedged back to Euro to reduce currency risk for a euro investor.

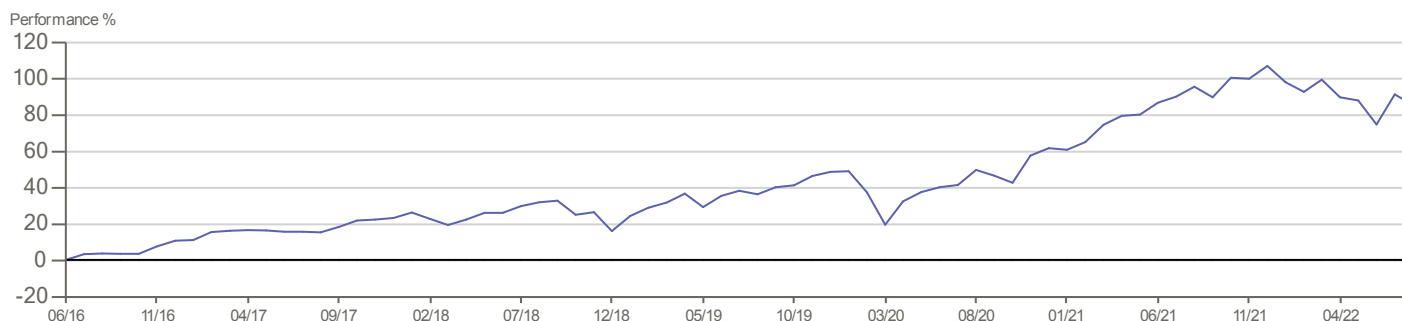
