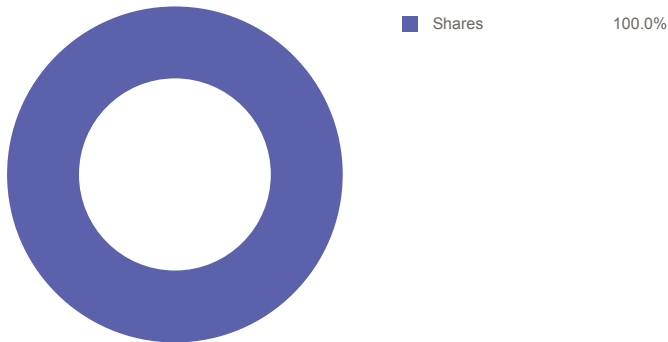

The fund largely captures the characteristics of the underlying MSCI World Small Cap Index in terms of country and industry exposure. The fund is designed for investors seeking potentially higher returns from a broader equity base.

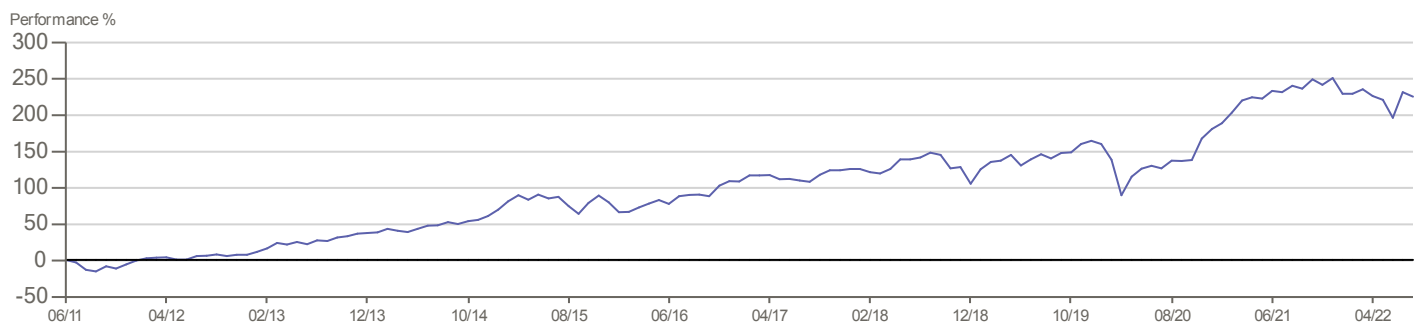
