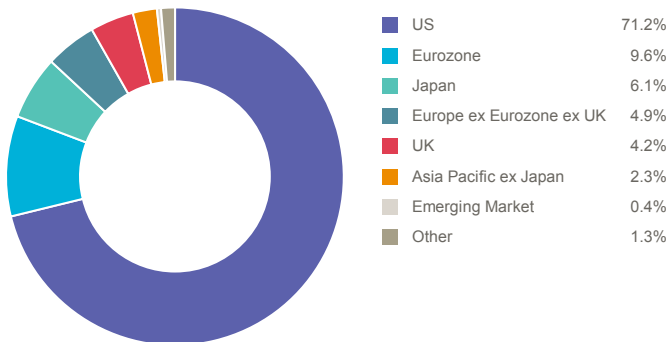

The Partial Currency Hedge Fund is a passively managed fund that invests 100% in global equities. The fund aims to perform in line with the MSCI World Index with 40% of the non Euro currency exposure hedged back to Euro to reduce currency risk for a Euro investor.

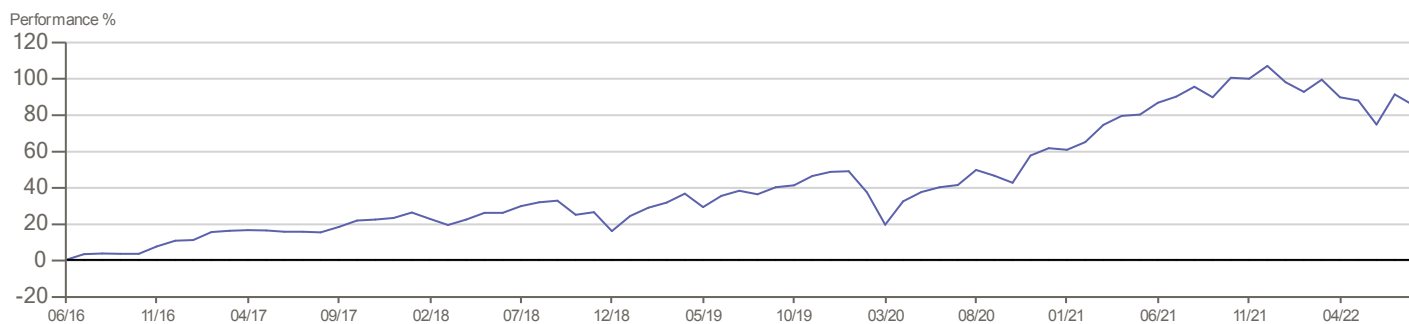
