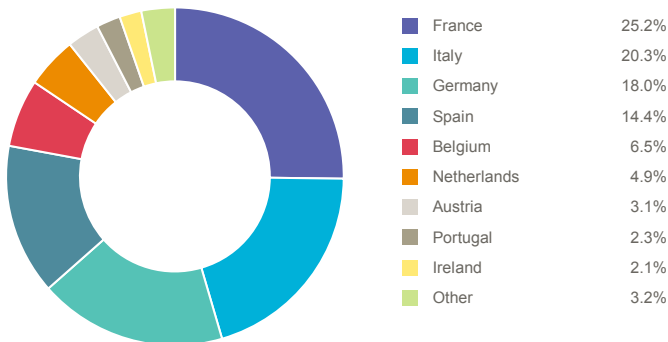

FUND DESCRIPTION

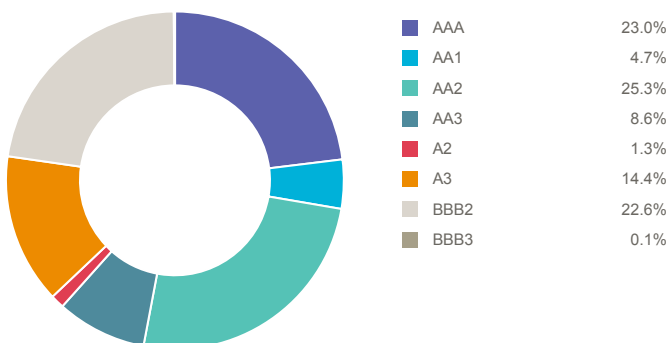
