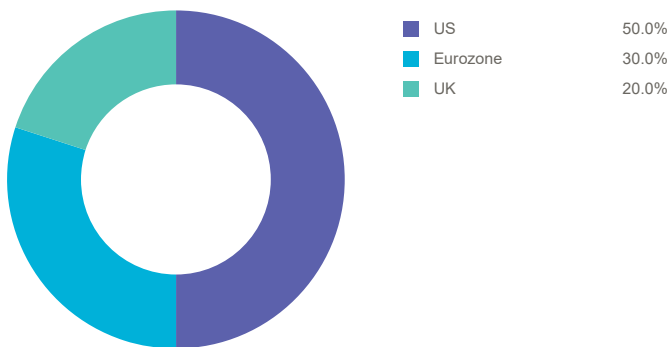

## FUND DESCRIPTION

This investment strategy (sometimes called the Put Sell Strategy) sells protection to investors for the global equity markets and in return a payment or premium is received. The protection periods run for approximately a month at a time and there is one sold approximately each week. The first 5% of any losses on global equity markets are not covered by the protection sold but thereafter the investment strategy will pay out on any monthly losses over 5%. The strategy holds cash to meet any pay outs and no leveraged is employed within it. Our experience is that as typically there is excess demand for protection on global equity markets, the price of the protection is expensive relative to fair value. Therefore, it pays to sell this protection to earn the premium.

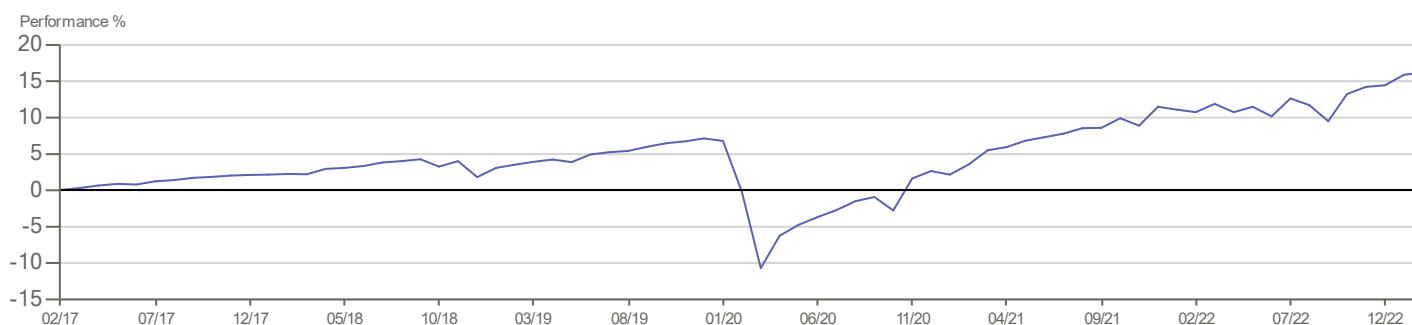
