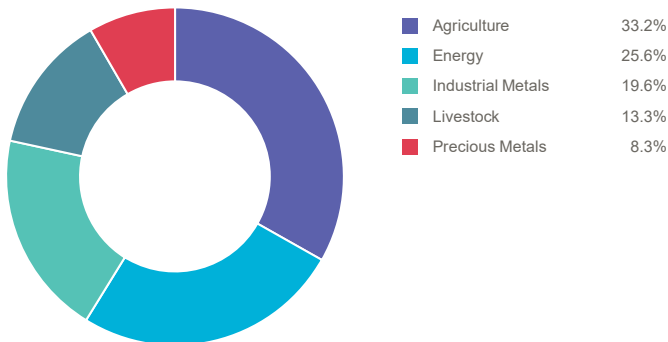

This fund is a passively managed fund that provides exposure to commodities. The fund aims to perform in line with the S&P Goldman Sachs Light Energy Enhanced Total Return Index. The 'Enhanced' Index aims to deliver a return which over the medium to long-term, exceeds that of the S&P GSLE Index by minimising the roll costs associated with investing in commodity futures. The base currency of the Index is US Dollars (USD). The Indexed Commodity Fund is priced in Euro and takes full currency exposure to the USD.

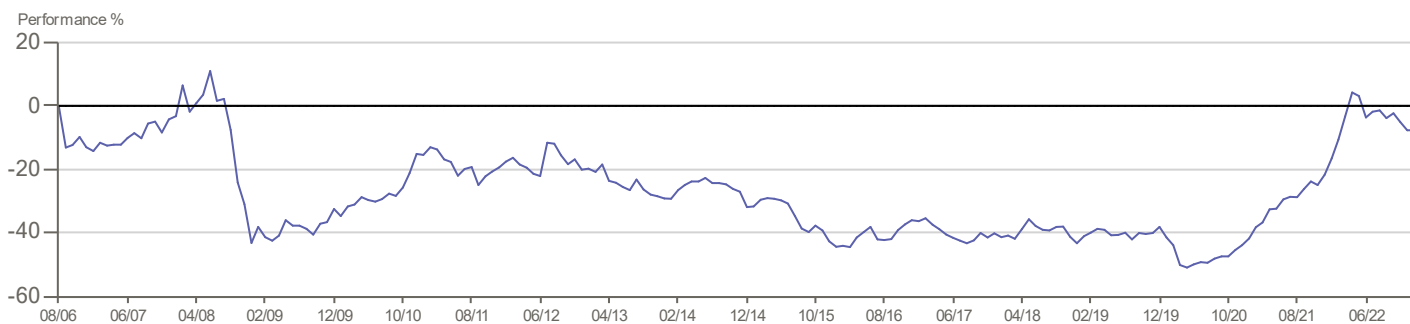
